



# The report is the first joint contribution from the Asia-Pacific countries to the LSC


The report was jointly submitted to the LSC by the 9 NSLI participating States as a working paper (A/AC.105/C.2/L.318).






#### Main Findings #1: Expansion of space activities and actors in the NSLI States makes national space legislation more important



 Establishment of national space legislation




\*Malaysian Space Agency was formed through merging of ANGKASA (former space agency in Malaysia, established in 2002) and Malaysian Remote Sensing Agency

#### Main Findings #2: Increasing number of national space legislations are enacted but challenge remains

- Outer Space Treaty: A foundational international norm
- National space legislations: More States enacting since 2000
- Further laws and regulations needed:
  - ✓ i.e., Registration of space objects: yet to be a common practice.
- Establishing national legal frameworks in line with the advancement of space activities: "a common challenge"

## Main Findings #3: NSLI facilitates the sharing of information and fruitful discussions on legal challenges and best practices at regional and international levels

♦ NSLI's significance and implications

**Regional Perspective** 

- Enhancing space law capacity through mutual learning of diverse legal practices.
- ✓ Building a collaborative platform to tackle common regional issues.

**International Perspective** 

- Contributing to the global agenda, such as the sustainability of space activities and the stable use of outer space.
- Promoting national space policy & law in line with international regimes through contributing to UNCOPUOS/LSC agendas, establishing regional cooperative mechanism, and enhancing the implementation of the Outer Space Treaty.

## **Conclusion and Way Forward**



NSLI = an effective regional model for enhancing capacities in establishing and implementing national space legislation

#### **D** NSLI's Unique features:

- Community building among the space law & policy practitioners in the region.
- Mutual learning of States' practices through exchanging information using a common format.
- Joint analysis and report drafting on the status of space-related laws in the region.
- Direct contribution to the UN agendas and global space community.
- Building a foundation for future discussions on common regional issues.
- Establishment of a new WG dedicated to space policy and law at the APRSAF-27, 2021.
