## CoCoSL Translation Challenges

Difficulties concerning terminology, language barriers and cultural differences were often issues that had to be resolved by the Editorial Teams.

For example:

A lack of direct analogies to terms like “duty of care” or “piercing the corporate veil” in the Russian Version.

Translating “responsibility” and “liability” in the Chinese Version:

Responsibility: 国际责任 (original one) - 国际责任 (finalised)

Liability: 国际责任 (original one) - 国际损害赔偿 责任 (finalized)

In the English version “internationa**l** law” is written in small letters, while in the Spanish Edition capital letters “INTERNATIONAL LAW” are used in accordance with Spanish tradition that “DERECHO” in capital letters refers to the legal system as a whole and in small letters “derecho” when referring to an individual rule.
