EU-Africa Cooperation in Space

- Enhanced long-term strategic cooperation for the integration and deployment of African requirements and needs in Copernicus Services through a cooperation framework: <u>GMES & Africa Initiative</u>
- Promote the development of local capacities (institutional, human and technical) for the access and exploitation of EO-based services on operational basis for sustainable development in Africa
- GMES & Africa was launched in Lisbon, Portugal on December 7, 2007 during the 2nd EU - Africa Summit as a response to the Maputo Declaration of 2006
- Enable the two continents to jointly solve and address global challengs SDGs, climate change, food security, emergency, security among others

EU-Africa Cooperation in Space (Contd.2)

- Establishment of the Space Troika in 2011
- Coordination Team to oversee the Evolution of GMES & Africa (2011)
- Mobilization of African and EC institutions

Adoption of the African Space Policy and Strategy by the Heads of State and Government


Space Policy and Strategy to formalize a sustainable African Space program with the following themes:



Funding

- GMES& Africa is funded by the European Commission through the funded Pan African Envelope: Euro 29.5M earmarked for this initiative:
 - 17.5M for Grants
 - o 6M for Staffing, Program Management, coordination, outreach and capacity building among others
 - 6M for JRC and Technical Assistance Team (TAT)
- AUC is the Delegated Authority for Grants and management
- Continued support from EC Institutes (JRC, EUMATSAT, ESA etc.) to complement
- GMES & Africa Coordinator Secretariat internal experts support (Euro 0.5M)

Implementation methodology

Official Launch of GMES & Africa: November, 2016

Grants Call for Proposals in two lots:

- Water & Natural Resources Services
- 2. Marine & Coastal Regional Services

Each of these 2 Services include 3 segments constituted as follows:


- (i) Segment A: Consolidation of existing application(s)


- Water and Natural Resources Service 15 applications:

 - III. Consortia will be assessed on a set objective criteria based on the following principles:
 - Adequate regional coverage and policy mandate
 - ii. Technical capacity
 - iii. Financial and Human Resources
 - iv. Experience in regional programmes and international collaboration
 - v. Involvement of private sector // academia
