

# SUMMARY OF SCHEDULED MEETINGS

# 690<sup>th</sup> meeting

Opening of the session [1]

The session was opened at its 690<sup>th</sup> meeting.

Adoption of the agenda [2]

The provisional agenda (A/AC.105/L.292) was adopted.

Statement by the Chair [3]

The Chair made a statement outlining the work of the Committee.

General exchange of views [4]

The Committee began its consideration of this item with statements by the representatives of Chile on behalf of the Group of 77 and China, Panama on behalf of the Latin America and the Caribbean Group, Luxembourg and the observer for the European Union on behalf of the European Union, Austria, Ecuador, Germany, Poland, Tunisia, the Republic of Korea and the Russian Federation.

The Director of the Office for Outer Space Affairs made a statement on the work of the Office.

The Committee decided to invite the representatives of Angola, the Dominican Republic, El Salvador, Israel, Kuwait, Mauritania, Oman, Panama, Qatar, Sri Lanka and the United Arab Emirates to participate in the session as observers.

The Committee decided to invite the representatives for the European Union, the Holy See, the League of Arab States, the Sovereign Military Order of Malta and the State of Palestine to participate in the session as observers.

# 691<sup>st</sup> meeting

### General exchange of views [4]

The Committee continued its consideration of this item with statements by the representatives of Algeria, Canada, China, Cuba, France, India, Thailand and Venezuela, (Bolivarian Republic of).

The observers for the Asia-Pacific Space Cooperation Organization (APSCO) and for the Space Generation Advisory Council (SGAC) also made statements.

#### Ways and means of maintaining outer space for peaceful purposes [5]

The Committee began its consideration of this item with a statement by the representative of the Republic of Korea.

## Report of the Scientific and Technical Subcommittee on its fifty-first session [6]

The Committee began its consideration of this item with statements by the representatives of Chile on behalf of the Latin America and the Caribbean Group, Austria, Germany, Japan and Syria.

#### Special presentations

Presentations were made by the representative of Italy on "The Italian Contribution to space exploration", by the representative of Japan on "Japan's Human Space Activity 30-Year History" and by the representative of China on "Operation and Development of BeiDou Navigation Satellite System".
