

### SUMMARY OF SCHEDULED MEETINGS

### 937th meeting

Opening of the session and adoption of the agenda [1]

The session was opened at its 937<sup>th</sup> meeting by the Director of the Office for Outer Space Affairs.

The Legal Subcommittee began its work by electing its Acting Chair, Ms. Laura Jamschon Mac Garry of Argentina, for the period 27-29 March.

The provisional agenda (A/AC.105/C.2/L.299) was adopted.

Statement by the Chair [2]

The Acting Chair made an opening statement outlining the work of the Subcommittee.

Organization of work

The subcommittee decided to invite the representatives of Cyprus, Denmark, Dominican Republic, Finland, Nepal, Norway, Paraguay and Singapore to participate in the session as observers.

The Subcommittee also decided to invite the representative of the African Union Commission and the European Union to participate in the session as observers.

### General exchange of views [3]

The Subcommittee began its consideration of this item with statements by the representatives of Algeria, Austria, Belgium, China, Costa Rica on behalf of G77+China, Ecuador, Indonesia, New Zealand, Pakistan and Venezuela (Bolivarian Republic of) on behalf of the Latin America and Caribbean Group.

The observer for the European Union also made a statement.

### 938th meeting

### Symposium

A symposium on the theme "Legal models for exploration, exploitation and utilization of space resources 50 years after the adoption of the Outer Space Treaty" was held during the  $938^{th}$  meeting of the Legal Subcommittee.

The Symposium was co-chaired by the Presidents of the International Institute of Space Law (IISL) and the European Centre for Space Law (ECSL). The Acting Chair of the Legal Subcommittee made introductory remarks.
