I. Introduction


A. Opening of the session

- 1. The Legal Subcommittee of the Committee on the Peaceful Uses of Outer Space held its sixty-third session at the United Nations Office at Vienna from 15 to 26 April 2024. At its 1054th meeting, on 15 April, Santiago Ripol Carulla (Spain) was elected Chair for the period 2024–2025, pursuant to General Assembly resolution 78/72.
